If you are interested in obtaining documents that fall with the requirements of the FOIA, you may submit a Freedom of Information Act (FOIA) Request in writing to the Livingston County Road Commission, 3535 Grand Oaks Drive, Howell, Michigan 48843, Attention: FOIA Coordinator.

Please be advised that upon receipt of a FOIA request, the Road Commission has five (5) business days in which to respond (six (6) business days if received via fax or email), in accordance with the Act, and the requesting party will be charged for staff research time, copies of any documents requested, and postage (if mailed). If an extension of time is necessary in order to fulfill a FOIA request, the Road Commission will notify the requesting party in writing, at which time an additional ten (10) business days will be permitted to the agency, in accordance with the Freedom of Information Act.
